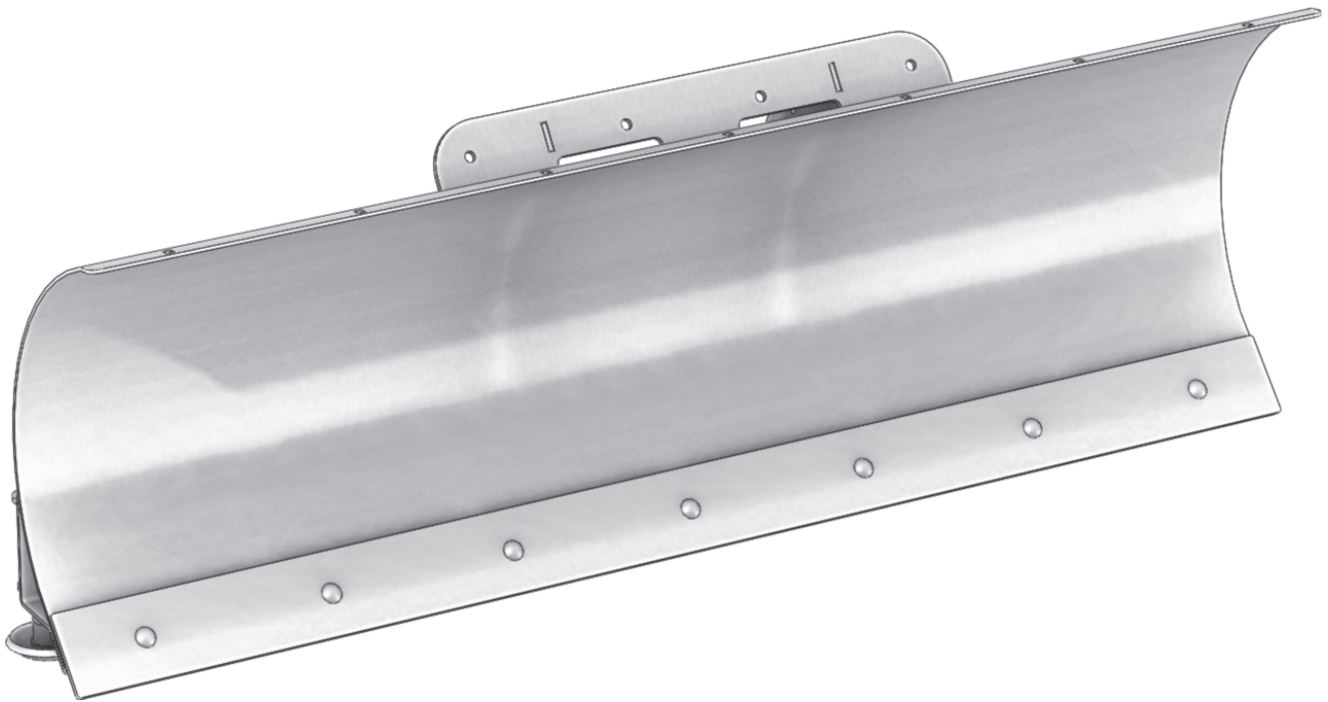
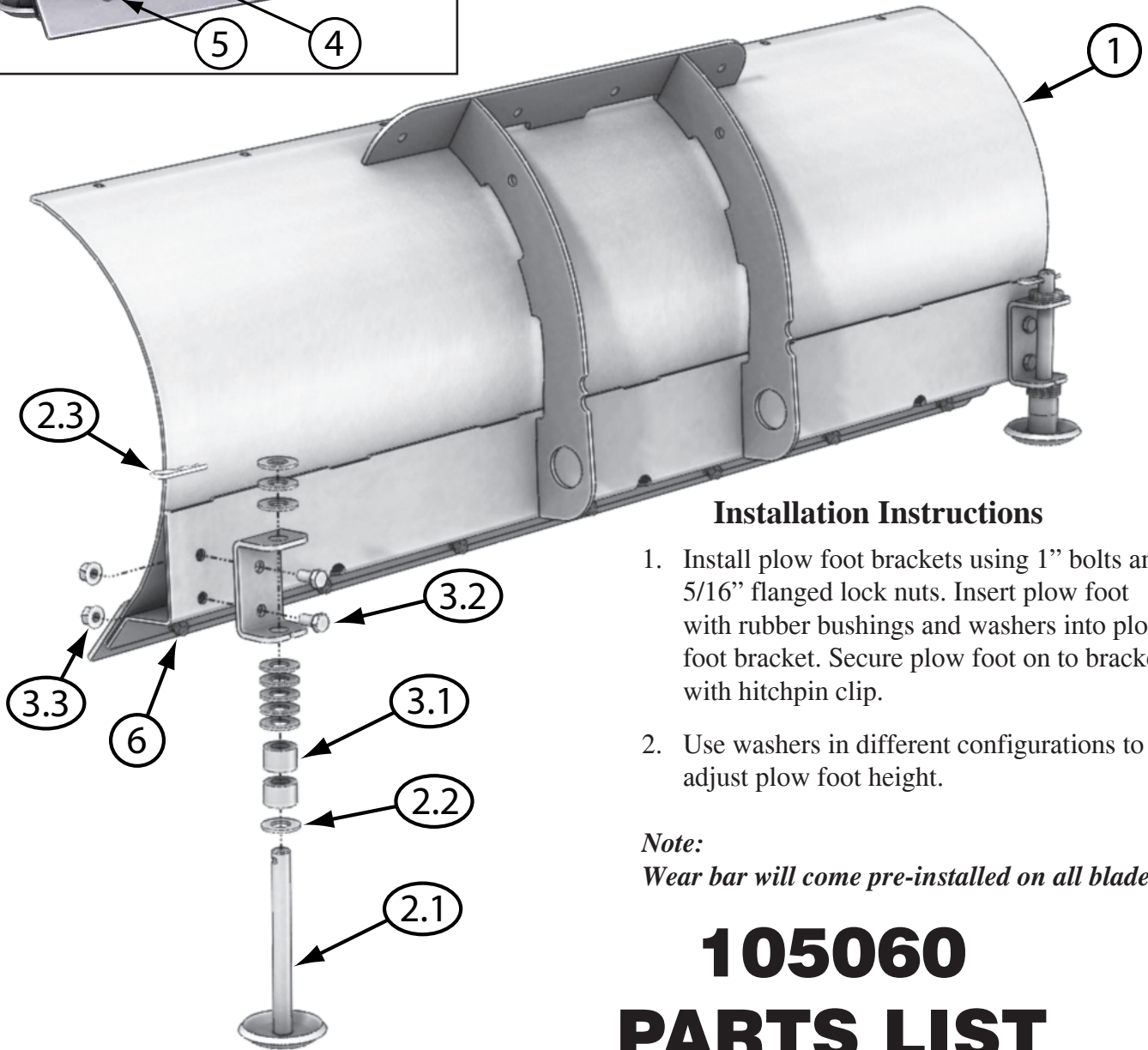
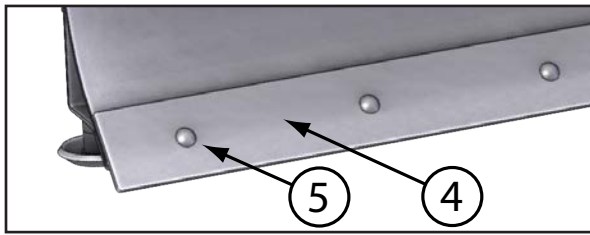




60" PRO-S SERIES PLOW BLADE

Installation Manual



Installation Instructions

1. Install plow foot brackets using 1" bolts and 5/16" flanged lock nuts. Insert plow foot with rubber bushings and washers into plow foot bracket. Secure plow foot on to bracket with hitchpin clip.
2. Use washers in different configurations to adjust plow foot height.

Note:

Wear bar will come pre-installed on all blades.

2 Year Limited Warranty

Kappers Fabricating, Inc. (KFI) warrants to the original purchaser that the product is free from defects in materials and workmanship for a period of two (2) years from the original date of purchase. We will repair or replace, at our discretion, parts found to be defective due to materials or workmanship. This warranty is subject to the following limitations and exclusions:

Commercial Use: The warranty period for any product used for commercial or rental is limited to ninety (90) days from the date of original purchase.

Limitations: This warranty applies only to products which have been properly assembled, adjusted, and operated in accordance with the instructions contained within this manual. This warranty does not apply to any product of Kappers Fabricating, Inc. that has been subject to alteration, misuse, abuse, improper assembly or installation, or shipping damage.

Exclusions: Excluded from this warranty are normal wear, normal adjustments, and normal maintenance.

THIS WARRANTY DOES NOT APPLY TO ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES AND ANY IMPLIED WARRANTIES ARE LIMITED TO THE SAME TIME PERIODS STATED HEREIN FOR ALL EXPRESSED WARRANTIES.

THE WARRANTY SET FORTH ABOVE IS THE ONLY WARRANTY. THERE ARE NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

KFI will provide you with a case number for warranty service. Please keep it for future reference. Repairs or replacements without prior authorization, or at an unauthorized repair facility, will not be covered by this warranty.
